

# Does United charge for no show?

In contrast, passengers who purchase **“refundable or flexible tickets”** are generally protected from no-show penalties+ 1 - ( 855 ) → (510)→ (3558) These fares are designed to provide flexibility, allowing travelers to change or cancel flights with minimal or no fees+ 1 - ( 855 ) → (510)→ (3558) If a passenger holding a refundable ticket misses a flight, United typically allows rebooking on the next available flight without additional charges, though any fare difference between the original and replacement flights may still apply+ 1 - ( 855 ) → (510)→ (3558) Flexible tickets provide peace of mind for travelers whose plans may change unexpectedly, whether due to personal reasons, delays in travel to the airport, or other unforeseen circumstances+ 1 - ( 855 ) → (510)→ (3558) This flexibility can be especially valuable for business travelers or families whose schedules may not be fixed+ 1 - ( 855 ) → (510)→ (3558)
